What is your role at CPCS and how long

have you been a poison expert? I have been a Toxicology Management Specialist for the California Poison Control System for five years. I answer calls from the public, as well as health care providers, with questions about potential poisonings and exposures. I have experience increasing poison awareness among health care students. I've given lectures to pharmacy and nursing students at the University of California San Francisco and the University of California Davis. These lectures help health care students utilize our poison prevention resources regardless of the field they end up in. They also help health care students pursue a future career at the Poison Center, ensuring experts in the field to assist with poison exposures in California.

Tell us about yourself: I graduated from the University of Maryland with a Doctor of Pharmacy degree and completed my pharmacy residency at the University of California Davis Medical Center. During my residency, I worked in the Intensive Care Unit, Emergency Department, and Poison Control Center and witnessed the very specialized knowledge in the unique subject area of toxicology, which fascinated me. Since then, I fell in love with the field and decided to pursue a career at the Poison Center.

Poisoning resulted in more deaths compared to other unintentional injuries, including motor vehicle traffic accidents and drowning. Nationally, a total of 87,415 people died from poisoning in 2020 across all ages, races, and gender.
